**KENAI PENINSULA BOROUGH
ORDINANCE 2007-19-37**

**AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT FROM THE
DENALI COMMISSION IN THE AMOUNT OF \$50,000 FOR JUNK VEHICLE
REMOVAL IN THE VILLAGE OF TYONEK**

WHEREAS, one of the primary goals of the borough's solid waste program is to reduce the number of abandoned and junk vehicles that create health and safety hazards for our residents and litter our rural areas; and

WHEREAS, the borough committed \$10,000 through its fiscal year 2007/2008 budget to survey and identify junk vehicles in Tyonek; and

WHEREAS, additional funding is needed to collect, crush, and transport the vehicles to an appropriate disposal site; and

WHEREAS, the Denali Commission has funding available through its Solid Waste Program to assist communities in their solid waste projects; and

WHEREAS, the Solid Waste Department submitted a grant application to the Denali Commission in the amount of \$50,000 to conduct a junk vehicle removal program in the Village of Tyonek; and

WHEREAS, the borough has received a notice of award from the Denali Commission for a vehicle collection and removal project in Tyonek; and

WHEREAS, as grants from the Denali Commission are for only one year and the Solid Waste Department would like to conduct this project during suitable weather conditions, a shortened hearing date has been requested;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


SECTION 1. That the mayor is authorized to accept a grant from the Denali Commission in the amount of \$50,000 and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.

SECTION 2. That grant funds in the amount of \$50,000 are appropriated to account 271.94910.8DCSW.48311 (Miscellaneous Grant Fund Capital Projects).

SECTION 3. That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.


SECTION 4. This ordinance shall become effective immediately upon its enactment.

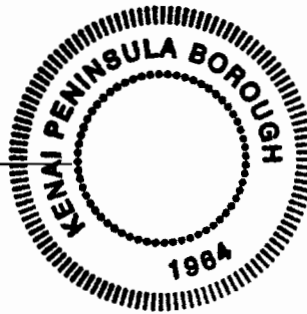
