KENAI PENINSULA BOROUGH ORDINANCE 2007-19-44

AN ORDINANCE APPROPRIATING \$190,000 IN THE SCHOOL REVENUE CAPITAL PROJECT FUND FOR TRANSFER TO THE BOND FUNDED CAPITAL PROJECT FUND FOR SUPPLEMENTAL COSTS ASSOCIATED WITH REPLACING WINDOWS AT SOLDOTNA ELEMENTARY SCHOOL

- WHEREAS, Ordinance 2006-19-44 appropriated \$2,588,000 in general obligation bonds for school capital improvement projects including \$300,000 for replacement of windows on the south wall (the core area) at Soldotna Elementary, which is approximately half of the windows that need to be replaced; and
- WHEREAS, the existing windows at the core area of the school are 45-50 years old and in need of replacement; and
- WHEREAS, professionals specializing in this type of work have indicated that the manner of construction of the windows and walls in the core area of the building prohibits replacing just the windows, but requires that to ensure structural integrity and proper building closure, the windows and wall panels must be replaced as a unit; and
- WHEREAS, due to the need to replace the wall panels in addition to the windows, the cost of the project has increased from an estimated \$300,000 to a projected amount of \$490,000; and
- **WHEREAS**, the School Revenue Capital Project Fund has fund balance that could be appropriated for the additional funds needed to complete the replacement of these windows;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That \$190,000 is appropriated from the School Revenue Capital Project Fund, fund balance to account 400.94910.00000.50401, transfer to Bond Funded Capital Project Fund.
- **SECTION 2.** That \$190,000 received from the School Revenue Capital Project Fund is appropriated in the Bond Funded Capital Project Fund, account 401.76010.7WDOW.49999, to complete the above-described phase of the Soldotna Elementary Window Replacement project.
- SECTION 3. That this ordinance takes effect immediately upon its adoption.
