3. Ordinance 2008-14, authorizing the Sale of Certain Parcels of Borough Land by Sealed Bid.

Memorandum reviewed by Marcus Mueller

Land Management has identified seven parcels of land that are deemed surplus to the borough's needs for land holdings and which could be prepared for marketing for a competitive market value land sale by sealed bid. Maps showing the location of each parcel were included in the packet.

Minimum bids will be proposed prior to hearing with the assistance of the Assessing Department.

The bid opening is proposed for October 24, 2008. A sale brochure will be prepared which will delineate the parcels and explain the sealed bid procedures. Notice of the Land Sale will be published in accordance with KPB 17.10.110, and the brochure will be made available on the Borough's Land Management website.

The ordinance would authorize the Mayor to conduct a sealed bid land sale of seven parcels of borough land. A resolution to classify these parcels will be introduced concurrent with the scheduled public hearing for this ordinance. Your consideration of this ordinance is appreciated.

END OF MEMORANDUM

Chairman Bryson opened the meeting for public comment. Seeing and hearing no one wishing to speak, Chairman Bryson closed the public comment period and opened discussion among the Commission.

MOTION: Commissioner Lockwood moved, seconded by Commissioner Isham to recommend enactment of Ordinance 2008-14, authorizing the sale of certain parcels of Borough Land by sealed bid.

Commissioner Johnson asked staff what the difference was between a sealed bid and an outcry auction. Mr. Mueller replied that staff has done both sealed bid auctions and outcry auctions, which have fair methodologies of conducting the auctions. They have found that sealed bid procedures work very well which allows for an open bid time. He stated the bid sale would be advertised in July, which gives staff ample time to market. The interested bidders could bid anytime preceding the October 24 deadline. The bidders wouldn't have to be in town or available for a certain time which gives an element of convenience. Mr. Mueller felt the sealed bid auction provides a fair and equitable way for people to place bids. He also felt it was a very good way of achieving a good market value because the folks that decide to bid have to ask what the property is worth to them. It takes some of the emotion out of it and provides for a very fair way of achieving fair market value.
