**KENAI PENINSULA BOROUGH
ORDINANCE 2008-19-02**

**AN ORDINANCE APPROPRIATING \$125,000 FROM THE FISCAL YEAR 2009
GRANT FUNDS SCHEDULED TO BE RECEIVED FROM THE STATE OF ALASKA
DEPARTMENT OF COMMERCE, COMMUNITY AND ECONOMIC DEVELOPMENT
TO PROVIDE FUNDING FOR THE NIKISKI BEACH ACCESS ENGINEERING
STUDY AND DESIGN PROJECT**

WHEREAS, developed public beach access in the Nikiski area is limited; and

WHEREAS, the borough has land and rights-of-way in the Nikiski area that could be developed to provide public beach access; and

WHEREAS, Goal 4.10 of the Kenai Peninsula Borough Comprehensive Plan is to encourage the provision of facilities for outdoor and indoor recreation for borough residents and visitors, Objective 2 of that goal is to plan for future recreational use of borough land which has recreational value, and Implementation Action A is to identify borough lands with recreational value that provide access to coastlines or recreational areas; and

WHEREAS, as part of the FY2009 State of Alaska Capital Budget, \$8,400,000 was appropriated for borough road improvements; and

WHEREAS, the borough administration has requested that \$125,000 of the above \$8,400,000 be appropriated for the Nikiski Beach Access Engineering Feasibility and Design Project, to evaluate the most suitable location for public beach access in Nikiski, and to design the project and administer construction; and

WHEREAS, the Road Service Area Board at its July 15, 2008, meeting recommended;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the assembly hereby appropriates \$125,000 from the Fiscal Year 2009 state grant for the Nikiski Beach Access Engineering Feasibility and Design project, for transfer and deposit to account number 434.33950.NBEAC.43011.

SECTION 2. That the mayor is authorized to execute all documents deemed necessary to effectuate the intents and purposes of this ordinance.

SECTION 3. That this appropriation is contingent upon receipt of the grant from the State of Alaska.


SECTION 4. This ordinance shall become effective immediately upon its enactment.
