## AN ORDINANCE ACCEPTING AND APPROPRIATING ON BEHALF OF NIKISKI FIRE SERVICE AREA A GRANT IN THE AMOUNT OF \$6,375 FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES

- WHEREAS, Nikiski Fire Service Area ("Service Area") applied for a grant under the 2008 Volunteer Fire Assistance ("VFA") grant program administered by the Alaska Department of Natural Resources, Division of Forestry; and
- WHEREAS, notice was received that a VFA grant in the amount of \$6,375 has been awarded to the Service Area for the purchase of fire fighting equipment; and
- WHEREAS, the VFA grant program requires a minimum 10 percent match of local expenditures to the grant funds, such expenditures to be made during the 2008 calendar year; and
- WHEREAS, the Service Area will meet the match requirement through expenditures made from its operating budget prior to December 31, 2008, for fire fighting equipment; and
- WHEREAS, at a regular board meeting held on August 13, 2008, the Service Area Board of Directors recommended acceptance of this grant;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept a Volunteer Fire Assistance Grant from the Department of Natural Resources on behalf of Nikiski Fire Service Area and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That grant funds in the amount of \$6,375.00 are appropriated to the following Service Area account: 206.51110.9VFA2.48514 Firefighting/Rescue Equipment account.
- **SECTION 3.** This ordinance shall become effective immediately upon its enactment.
