**KENAI PENINSULA BOROUGH  
ORDINANCE 2008-19-19**

**AN ORDINANCE APPROPRIATING \$220,000 FROM SOUTH KENAI PENINSULA HOSPITAL SERVICE AREA CAPITAL PROJECT FUND FOR THE PURCHASE OF SEVERAL CAPITAL EQUIPMENT ITEMS NOT PREVIOUSLY BUDGETED**

**WHEREAS,** South Peninsula Hospital is in need of acquiring four capital equipment items totaling \$220,000, which were not previously budgeted; and

**WHEREAS,** the four capital equipment items are an anesthesia monitor costing \$16,000, sleep lab equipment costing \$30,000, radiology satellite equipment costing \$74,000, and CPSI computer server along with related software/hardware and workstations costing \$100,000; and

**WHEREAS,** the need for these items came about after the FY2009 budget was approved; and

**WHEREAS,** based upon financial analysis done by hospital staff, the purchase of this equipment will increase revenues, reduce operating expenses, generate positive cash flow, and provide better service to the residents of the South Kenai Peninsula Hospital Service Area, and

**WHEREAS,** the South Kenai Peninsula Hospital Service Area board at its August 14, 2008 and September 11, 2008 meeting authorized the use of service area funds to purchase the requested equipment items;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That funds in the amount of \$220,000 are appropriated from the South Kenai Peninsula Hospital Service Area Capital Project Fund, fund balance to the following accounts as follows:





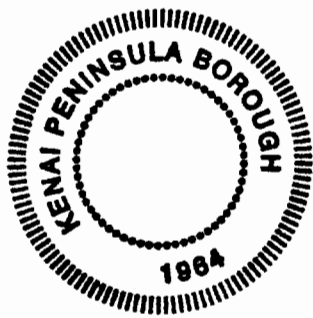
**SECTION 2.** This ordinance shall become effective immediately upon its enactment.
