The Alaska Division of Homeland Security and Emergency Management (DHS&EM) is pleased to award the Kenai Peninsula Borough the amount of \$523,750.00 under the 2008 State Homeland Security Program for the performance period of October 1, 2008, through December 31, 2010.

Funding from this program is provided to enhance the ability of states, territories, and urban areas to prepare for, prevent, and respond to terrorist attacks and other all-hazards events.

Local jurisdictions historical grant performance was a part of the scoring considered during the 2008 Homeland Security grant review process. DHS&EM staff performed an analysis of grant performance in 10 areas. The Kenai Peninsula Borough scored 100 out of a potential 100, in overall grant performance.

A voluntary interagency review committee comprised of 10 representatives from various disciplines at State and local levels convened the week of August 4, 2008, to review eligible projects, local jurisdiction grant performance, and determine award allocation amounts. The result of this work is reflected in the allocated category funds identified in the project budget detail attached with the award document.

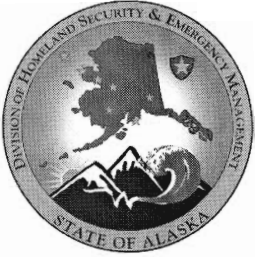
