On December 2, 2008 you will be asked to vote on the South Kalifornsky Beach Road Natural Gas Line Extension. (USAD) Since I have worked on this project I would like to give you some background that I hope will help in your favorable vote for the "Resolution of Necessity".

Since this project began the costs have increased by some \$53,000.00. This has happened in just the last 2 months. The explanation for this is that these are now engineered costs not just an estimate. Additionally the EPA requires special treatment while displacing the ground while digging the pipeline trench. (SWPPP).

ENSTAR's engineering has delayed our petition three months so we are now under the gun to get the Assembly's approval before the end of the year 2008 or we will be faced with even more increases in 2009. This in turn has shortened our signature gathering time as well since the Kenai Borough Assembly only meets once in December. This ends up our not having the full 30 days we allowed to gather certifiable signatures.

Mickey Mullins previously worked on a like project two and one half years ago and fell short of the needed 70 percent because the scope of the project was too large and also because of the 16 sub standard sized parcels at the beginning of the project. These are parcels which cannot provide the necessary separation for water and septic for building. We have tried to have the Borough legal exempt these sub standard lots and found that they could not because of code restrictions for a USAD. The parcel owners in this petition have been advised of our desire to eliminate these parcels and that they would all share in higher assessments because of this. Several parcel owners are currently removing lot lines thus reducing the number of these sub standard parcels in the project.

This is a summary of the projects background but the real issue is that when this project is completed the petitioners will save on the ever rising cost of heating their homes. One of the parcel owners has stated they would save over \$10,000.00 in the first five years. Others will save substantially as well. Secondly, if this petition does not pass then everyone farther down K-Beach will never be able to enjoy the benefits of natural gas. This project is greater than just the 74 parcels in this proposed USAD.

Please consider a favorable vote for this petition.....
