## KENAI PENINSULA BOROUGH PLANNING COMMISSION NOTICE OF PUBLIC HEARING

Public notice is hereby given that a petition has been submitted for the creation of a **Single Family Residential (R-1) local option zoning district (LOZ)** on property in the **Funny River area**. You are being sent this notice because you are a landowner or leaseholder of property located within the required 300-foot notification radius of the subject property, and are invited to comment.

The property included in the LOZ petition under consideration is described as follows:

- Location: All of Funny River Grove Subdivision located within the SW1/4 of Section 24, T5N, R9W, Seward Meridian, Kenai Recording District, Alaska.
- **Petitioner and Owner**: Arvind & Dipali Phukan Bruce & Nola Sharkey

**Request**: The petition and owner requests that 52.622 acres of Funny River Grove Subdivision be zoned as Single-Family Residential (R-1).


