Dear Borough Assembly Members and Mayor Carey,

My name is Belinda Espy, and I am writing to you as a resident of this borough and as a teacher in the school district. This summer is an exciting time for me because I will be getting married and looking to start a family in the near future. I am a person who chooses to live in this area because I love it here and have faith in the successfulness of our future. I also live here because I like my job and believe that my impact will spur individuals who can develop smart solutions to the problems that we are facing today in our community and nation.

As an educator, expectations for my school, students, and our Borough, are heightened every year. Not funding education to the cap is an action that does not support our students and the future of our borough. This is an especially detrimental recommendation at a time such as this. Within the next three to five years, 40% of our teachers will retire. The only teachers that will be recruited into this area are teachers, such as me, that love it here and are dedicated to education of the students that live here. They will not do it for the money or the nonexistent retirement plan. Failing to fund education to the cap could potentially cut my job and the jobs of many others. Cutting new positions and teachers will negatively impact our borough. I believe it is critical to learn from the experienced teachers around me so that when the new hiring boom occurs, I can be a leader that holds our schools together and secures the future of our borough through providing our students with a quality education. Funding education at levels below the cap allowed by law will influence the decisions my husband and I make for our family, which will in turn impact the future of our borough. Questions we are forced to explore as a result of the low priority placed on education as revealed by below -the- cap funding include:

- Can we afford to have a house in this borough with my potential job cut?
- Will we raise our children in a borough that is cutting their education?
- Will teachers come to a borough where class sizes are high and incentives low?
- How will educators increase students learning with a decrease in funding?
- How will the borough maintain student learning in the future if good teachers move elsewhere?

As a tax payer and resident of this borough, I ardently support the full funding of schools. Assembly members are being misguided by a vocal minority if they think that all residents support below the cap funding as a means to a tax break.
