KENAI PENINSULA BOROUGH ORDINANCE 2008-19-47

AN ORDINANCE APPROPRIATING \$260,059 FROM THE GENERAL FUND TO PROVIDE SUPPLEMENTAL FUNDING FROM LOCAL SOURCES FOR SCHOOL PURPOSES DURING FISCAL YEAR 2008-2009

- WHEREAS, in Ordinance 2008-19, the borough assembly appropriated \$40,886,886 from local sources for school purposes; and
- WHEREAS, funding provided for school purposes in Ordinance 2008-19 was based upon estimated enrollment of 9,053; and
- WHEREAS, actual enrollment for Fiscal Year 2008-2009 (FY09) is 9,256, an increase of 203 from the estimated enrollment; and
- WHEREAS, this increased enrollment generated additional state revenue of \$1,130,688 and a potential increase to local effort in the amount of \$260,059; and
- WHEREAS, the school district has adopted a revised budget of \$140,414,120 which takes into account the increase in state funding and assumes funding at the cap from the borough; and
- WHEREAS, the school board has requested approval of this supplemental appropriation, and the revised FY09 school district budget was presented in accordance with revised foundation calculations; and
- WHEREAS, funding for this supplemental appropriation is being provided by Secured Rural Schools and Community Self-Determination Act 2000 that was received in excess of the budgeted amounts;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. Subject to the provisions of this ordinance, \$260,059 is appropriated from the borough general fund, fund balance to the school district operations fund.

SECTION 2. That the borough assembly approves a revised total education budget for the fiscal year July 1, 2008 through June 30, 2009, as follows:

SECTION 3. That subject to the provisions of this ordinance, in addition to the amounts previously appropriated in Ordinance 2008-19, supplemental funding of \$260,059 is appropriated to the school fund as local effort. With this supplemental appropriation, total local funding for the school operations purposes and in-kind services for the year July 1, 2008 through June 30, 2009 are revised to read as follows:

SECTION 6. That this ordinance takes effect immediately upon its adoption.
