KENAI PENINSULA BOROUGH ORDINANCE 2008-19-55

AN ORDINANCE APPROPRIATING AN ADDITIONAL \$246,780 TO COVER COSTS IN EXCESS OF BUDGETED AMOUNTS FOR FIRE ALARM AND ADA UPGRADES AT NIKISKI COMMUNITY RECREATION CENTER AND AWARDING OF A CONTRACT

- WHEREAS, funds totaling \$650,000 were previously received from the state of Alaska for facility improvements at the Nikiski Community Recreation Center (NCRC) and were appropriated through Ordinance 2005-19-28 in the amount of \$175,000 and Ordinance 2008-19-10 in the amount \$475,000; and
- WHEREAS, approximately \$506,312 remains of the grant funds, which is available for ADA upgrades and installation of a fire alarm system at the NCRC; and
- WHEREAS, the estimate for the ADA upgrades and installation of a firm alarm system was \$385,000, and hazardous materials were subsequently identified within the project limits which contributed to the unanticipated high bids; and
- WHEREAS, the low responsive bid submitted by Blazy Construction of Soldotna, Alaska in the amount of \$628,180 is fair and reasonable, and the bidder is qualified to perform the work; and
- WHEREAS, the total budget for the ADA upgrades and fire alarm installation is now estimated at \$753,092; and
- WHEREAS, the administration is requesting that the additional funding of \$246,780 needed to complete this project be shared by the North Peninsula Recreation Center and the Land Trust Fund; and
- **WHEREAS**, the North Peninsula Recreation Service Area (NPRSA) at its April 27, 2009 meeting recommended enactment by unanimous consent;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That \$123,390 is appropriated from the Land Trust Fund, fund balance to account 250.21210.00000.50459, transfer to North Peninsula Recreation Service Area Capital Project Fund, to provide additional funding necessary to complete the fire alarm and ADA upgrades at the Nikiski Community Recreation Center.
- SECTION 2. That \$246,780 is appropriated from fund balance to account 459.61110.09092.49999 for supplemental funding for ADA upgrades and fire alarm installation at the Nikiski Community Recreation Center.
- **SECTION 3.** That Blazy Construction be awarded a contract for ADA upgrades and fire alarm installation at Nikiski Community Recreation Center.
- **SECTION 4.** That this ordinance takes effect immediately upon its enactment.
