**KENAI PENINSULA BOROUGH  
ORDINANCE 2008-19-56**

**AN ORDINANCE ACCEPTING AND APPROPRIATING ON BEHALF OF BEAR  
CREEK FIRE SERVICE AREA A GRANT IN THE AMOUNT OF \$8,998.20 FROM THE  
ALASKA DEPARTMENT OF NATURAL RESOURCES**

**WHEREAS,** Bear Creek Fire Service Area ("Service Area") applied for a grant under the 2009 Volunteer Fire Assistance ("VFA") grant program administered by the Alaska Department of Natural Resources, Division of Forestry; and

**WHEREAS,** notice was received that a VFA grant in the amount of \$8,998.20 has been awarded to the Service Area for the purchase of firefighting equipment; and

**WHEREAS,** the VFA grant program requires a minimum 10 percent match of local expenditures to the grant funds, such expenditures to be made during the 2009 calendar year; and

**WHEREAS,** the Service Area will meet the match requirement through expenditures made from its operating budget prior to December 31, 2009, for firefighting equipment; and

**WHEREAS,** at a regular board meeting held on May 14, 2009, the Bear Creek Fire Service Area Board recommended enactment by unanimous consent;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI  
PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept a Volunteer Fire Assistance Grant from the Department of Natural Resources on behalf of Bear Creek Fire Service Area and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.

**SECTION 2.** That grant funds in the amount of \$8,998.20 are appropriated to the following Service Area account: 207.51210.OVFA1.48514 - Firefighting Equipment

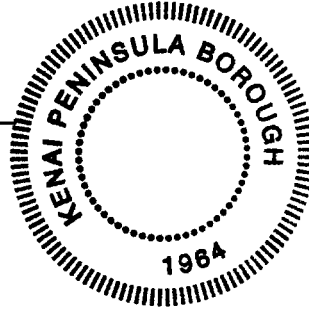
**SECTION 3.** This ordinance shall become effective immediately upon its enactment.
