**KENAI PENINSULA BOROUGH
ORDINANCE 2008-19-58**

**AN ORDINANCE APPROPRIATING AN ADDITIONAL \$140,000
TO COVER COSTS IN EXCESS OF BUDGETED AMOUNTS FOR ROOF
REPLACEMENT FOR SOLDOTNA ELEMENTARY SCHOOL AND
AUTHORIZATION TO AWARD A CONTRACT**

WHEREAS, funds totaling \$175,000 were previously received from the State of Alaska Department of Commerce, Community & Economic Development for Soldotna Elementary School Roof Section 400 and were appropriated through Ordinance 2005-19-29 in the amount of \$100,000, Ordinance 2007-19-19 in the amount of \$75,000, and \$130,000 was appropriated in Ordinance 2007-19-48 from bond interest funds, for a total amount of \$305,000; and

WHEREAS, approximately \$105,531 has been spent on project design and project management leaving \$199,469 for this project; and

WHEREAS, the low responsive bid submitted by Rain Proof Roofing, Anchorage, Alaska in the total extended bid amount of \$303,105 is fair and reasonable, and the bidder is qualified to perform the work; and

WHEREAS, the total budget for the Soldotna Re-Roof project is now estimated at \$445,000; and

WHEREAS, \$140,000 is available in the completed project Nikolaevsk School Re-roof Phase 2, account 401.71090.03NVK.49999; and

WHEREAS, these unexpended funds were interest earned on bond proceeds from the Seward Middle School, Ordinance 2003-19-03 on 8/05/03 and previously appropriated/redirected in Ordinance 2007-19-48; and

WHEREAS, introduction and enactment of this ordinance on shortened hearing is necessary to facilitate completion of these projects during the 2009 construction season.

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$140,000 is appropriated/redirected to Soldotna Elementary School Re-Roof project from account 401.71090.03NVK.49999 to account 400.76010.06199.49999; and

SECTION 2. That the Mayor has authorization to enter into a contract with Rain Proof Roofing, Anchorage, Alaska for Soldotna Elementary School (400 wing) Re-Roof project.


SECTION 3. That this ordinance shall become effective immediately upon its enactment.
