KENAI PENINSULA BOROUGH ORDINANCE 2008-19-60

AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT FROM THE STATE OF ALASKA IN THE AMOUNT OF \$21,350 FOR THE BOROUGH'S COASTAL MANAGEMENT PROGRAM'S PUBLIC ACCESS STUDY

- WHEREAS, the Borough has included the need for coastal erosion studies in its list of federal priorities for several years; and
- WHEREAS, the State has identified coastal erosion as a high priority concern under Alaska's Enhancement Grants Program 2006 Assessment and Strategy; and
- WHEREAS, the Alaska Coastal Management Program (ACMP) receives funding from the U.S. Department of Commerce, National Oceanic and Atmospheric Administration (NOAA), and the ACMP conducts a competitive grant program to award grants for scientific studies to participating districts under the Coastal Zone Management Act of 1972, Section 309; and
- WHEREAS, the Kenai Peninsula Borough Coastal District applied for a grant to inventory legal coastal public access points for the western Kenai Peninsula; and
- WHEREAS, the Borough has received notice of a grant award in the amount of \$21,350 for the Western Kenai Peninsula Legal Public Access Study; and
- WHEREAS, the Section 309 grant program does not require a local match; and
- WHEREAS, the public access study will assist the Borough in identifying areas of coastal erosion that result from inappropriate use of legal public access points; and
- WHEREAS, it is in the best interest of the Borough to accept the grant and continue its coastal erosion studies in order to help establish its coastal erosion policies; and
- WHEREAS, at its meeting of May 26, 2009, the Kenai Peninsula Borough Planning Commission recommended enactment by unanimous consent;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That the mayor is authorized to accept a grant from the State of Alaska in the amount of \$21,350 to conduct a public access study and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That the sum of \$21,350 is hereby appropriated to the following coastal zone management account: 251.21135.21082.49999.
- **SECTION 3.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.
- **SECTION 4.** This ordinance shall become effective immediately upon enactment.
