**KENAI PENINSULA BOROUGH  
ORDINANCE 2009-19-03**

**AN ORDINANCE ACCEPTING AND APPROPRIATING \$25,225 FROM THE ALASKA  
DEPARTMENT OF MILITARY AND VETERAN AFFAIRS, DIVISION OF  
HOMELAND SECURITY AND EMERGENCY MANAGEMENT, TO SUPPORT THE  
ACTIVITIES OF THE KENAI PENINSULA BOROUGH LOCAL EMERGENCY  
PLANNING COMMITTEE**

**WHEREAS,** the Kenai Peninsula Borough established the Local Emergency Planning Committee (LEPC) to meet requirements of the Emergency Planning and Community Right-To-Know Act; and

**WHEREAS,** the LEPC membership consists of private individuals, public entities, and industry representatives who serve as a public education and information source for disaster preparedness throughout the borough; and

**WHEREAS,** the Alaska Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management, has provided fiscal year 2010 baseline funding in the amount of \$25,225 to support LEPC activities; and

**WHEREAS,** the \$25,225 may be used for travel, support services, supplies, capital equipment purchases, and/or contractual services for the LEPC; and

**WHEREAS,** the Borough Office of Emergency Management will administer the grant on behalf of the LEPC for the purposes stated above; and

**WHEREAS,** as the grant program does not allow for indirect costs, and the grant is for a borough department funded by general funds, no borough administrative service fee will be charged for this grant; and

**WHEREAS,** because the State requires that the signed grant agreement be returned within 50 days, a shortened hearing date is requested;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept the \$25,225 grant from the Alaska Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management.

**SECTION 2.** That the grant funds in the amount of \$25,225 are hereby appropriated to Account No. 263.91120.LEP10.49999 – Project Account.


**SECTION 3.** That the mayor is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant, and to fulfill the intents and purposes of this ordinance.

**SECTION 4.** This ordinance shall become effective immediately upon its enactment.
