**KENAI PENINSULA BOROUGH  
ORDINANCE 2009-19-07**

**AN ORDINANCE REDIRECTING FUNDS PREVIOUSLY APPROPRIATED TO THE  
SOLID WASTE CAPITAL PROJECT FUND FOR THE PURCHASE OF EQUIPMENT  
NEEDED TO IMPLEMENT A JUNK VEHICLE REMOVAL PROGRAM TO  
CONTRACT SERVICES IN THE SOLID WASTE OPERATING FUND**

**WHEREAS**, Ordinance 2008-19 appropriated \$190,000 to account number 411.32220.09VEH.49999 in the Solid Waste Capital Project Fund for the purchase of equipment necessary to start a junk vehicle removal program, which included a wrecker/fork truck and establishment of a preparation station; and

**WHEREAS**, the administration would prefer to utilize these funds to contract for towing, preparation, crushing, and transporting junk vehicles to a recycle center; and

**WHEREAS**, contracting for these services is more appropriately accounted for in the Solid Waste Operating Fund; and

**WHEREAS**, an appropriation is needed to transfer these funds from the Solid Waste Capital Project Fund to the Solid Waste Operating Fund;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That project 411.32220.09VEH.49999 previously appropriated in Ordinance 2008-19 for the purchase of a wrecker/fork truck and establishment of a prep station including power connection is canceled.

**SECTION 2.** That the \$190,000 previously appropriated to project 411.32220.09VEH.49999 is transferred to account 411.32220.00000.50290, transfer to Solid Waste Fund.

**SECTION 3.** That \$190,000 is appropriated in the Solid Waste Fund, account number 290.32570.09VEH.43011 to contract for towing, preparation, crushing, and transporting junk vehicles to a recycle center.

**SECTION 4.** This ordinance takes effect immediately upon its enactment.
