KENAI PENINSULA BOROUGH ORDINANCE 2009-19-09

AN ORDINANCE APPROPRIATING \$63,000 IN SUPPLMENTAL FUNDING FOR THE KACHEMAK EMERGENCY SERVICE AREA

- WHEREAS, the Kachemak Emergency Services is in the first year of providing EMS and fire response to their residents and as part of this transition year, has identified the need to acquire some additional equipment and remodel their fire station; and
- WHEREAS, the Kachemak Emergency Services fire station is in need of remodeling estimated at \$10,000 to provide for an office for the administrative assistant and a storage area for safety equipment, which will help them to comply with OSHA standards; and
- WHEREAS, the number of volunteers (59) has exceeded projections, resulting in the need to purchase additional personal protective equipment and minor firefighting equipment with an estimated cost of \$23,000; and
- WHEREAS, a communication design engineer has indicated that the only way to address several blackout areas near Ruth Way Station and on the back side of the Bluff is the installation of a repeater in the Diamond Ridge area with simulcasting. The cost for this repeater is estimated to be \$30,000; and
- WHEREAS, the Service Area board at its September 10, 2009, board meeting authorized the use of service area fund balance to purchase the necessary items; and
- **WHEREAS**, approval by the assembly is necessary to appropriate the additional funds;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That \$63,000 is hereby appropriated from the KESA Operating Fund, fund balance to the following accounts:
 - 212.51810.00000.48760, minor fire fighting equipment, \$23,000
 - 212.51810.00000.50446, transfer to KESA Capital Project Fund, \$40,000

SECTION 2. That the amount of \$40,000 is hereby appropriated in the KESA Capital Project Fund, to the following accounts:

446.51810.0RPTR.48514, Repeater, \$30,000

446.51810.0RMDL.49125, Office Remodel, \$10,000

SECTION 3. This ordinance shall become effective immediately upon enactment.
