**KENAI PENINSULA BOROUGH
ORDINANCE 2009-19-12**

**AN ORDINANCE ACCEPTING AND APPROPRIATING GRANT FUNDS FROM THE
U.S. DEPARTMENT OF INTERIOR IN THE AMOUNT OF \$126,944 FOR PROJECTS
UNDER THE COASTAL IMPACT ASSISTANCE PROGRAM**

WHEREAS, the Coastal Impact Assistance Program (CIAP) was established under Section 384 of the Energy Policy Act of 2005 and authorizes the U.S. Department of Interior, Minerals Management Service to distribute \$250 million annually to Outer Continental Shelf oil and gas producing states and coastal political subdivisions (CPS); and

WHEREAS, the Kenai Peninsula Borough is an eligible CPS, participating in the Alaska Coastal Management Program and delegated to mitigate the effects of offshore oil and gas activities; and

WHEREAS, the Kenai Peninsula Borough Tier 1 Projects were approved by way of resolutions 2007-032 and 2008-017; and

WHEREAS, the U.S. Department of Interior, Minerals Management Service has approved CIAP funds in the amount of \$237,740 to complete the Tier 1 Projects, of which \$110,796 has been recognized by way of ordinances 2008-19-50 and 2008-19-054; and

WHEREAS, the balance of \$126,944 CIAP funds is available to the borough to complete the remaining Tier 1 Projects.

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept the above-described allocation from the U.S. Department of Interior, Minerals Management Service, in the amount of \$126,944 through the Alaska Coastal Impact Assistance Program, and is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the funds and fulfill the intents and purposes of this ordinance.


SECTION 2. That grant funds totaling \$126,944 are hereby appropriated to the following account numbers for the purpose of completing the projects approved:

SECTION 3. That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 4. This ordinance shall become effective immediately upon enactment.

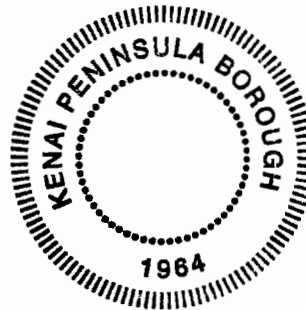
