KENAI PENINSULA BOROUGH ORDINANCE 2009-19-19

AN ORDINANCE APPROPRIATING \$374,605.14 FROM THE GENERAL FUND THROUGH THE SOLID WASTE DEPARTMENT TO PARTIALLY FUND THE CONSTRUCTION OF A TURN LANE ON THE STERLING HIGHWAY

- WHEREAS, the area of the Sterling Highway near the entrance to the Central Peninsula Landfill (CPL) has become hazardous due to the high volume of traffic turning at that location; and
- WHEREAS, turn lanes will benefit borough employees working at the CPL, landfill users, Alaska Department of Transportation (DOT) maintenance personnel, and all resident and tourist traffic utilizing this stretch of highway; and
- WHEREAS, DOT has estimated the cost of constructing turn lanes at the CPL to be approximately \$1,130,000; and
- WHEREAS, DOT has requested that the Borough provide funding of \$374,605.14 to assist in funding this project; and
- WHEREAS, as the Central Peninsula Landfill is the primary cause for this traffic issue it is appropriate that the funding should come from Solid Waste Department funds; and
- **WHEREAS,** approximately 95 percent of funding for the Solid Waste Department is provided by the general fund;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** The amount of \$374,605.14 is hereby appropriated from the General Fund fund balance to account number 100.94910.00000.50290, Transfer to Solid Waste, to be contributed towards the cost of constructing turn lanes on the Sterling Highway by the access to the Central Peninsula Landfill.
- **SECTION 2.** That \$187,302.57 is appropriated in the Solid Waste Fund account number 290.32010.00000.50407, Transfer to General Government capital project account.
- **SECTION 3.** That \$187,302.57 is appropriated to account 407.19010.10TRN.43011, project account number.

- **SECTION 4.** That all material costs incurred on this project with borough funds shall be paid on a reimbursable basis up to a total of \$374, 605.14 of actual project costs described on the Alaska DOT/PF Project Cost Estimate of Materials dated September 23, 2009.
- **SECTION 5.** The mayor is authorized to execute any documents necessary to fulfill the intents and purposes of this ordinance.

SECTION 6. That this ordinance shall take effect immediately upon its enactment.
