**KENAI PENINSULA BOROUGH
ORDINANCE 2009-20**

**AN ORDINANCE AMENDING CHAPTER FIVE, TRANSPORTATION, OF THE 2005
KENAI PENINSULA BOROUGH COMPREHENSIVE PLAN BY DELETING
APPENDIX F, "ALASKA DOT&PF STATEWIDE TRANSPORTATION
IMPROVEMENT PROGRAM KENAI PENINSULA BOROUGH PROJECTS",
AND ADDING A NEW APPENDIX J, "ALASKA DOT&PF STATEWIDE
TRANSPORTATION IMPROVEMENT PROGRAM
KENAI PENINSULA BOROUGH PROJECTS"**

- WHEREAS,** the assembly adopted a transportation plan in 2003, including Appendix F, Alaska DOT&PF Statewide Transportation Improvement Program, Kenai Peninsula Borough Projects; and
- WHEREAS,** the 2003 Transportation Plan was incorporated by reference in the 2005 Kenai Peninsula Borough Comprehensive Plan; and
- WHEREAS,** the Kenai Peninsula Borough (KPB) assembly has adopted resolution 2009-023, recommending 2010-2013 projects for the Alaska DOT&PF State Transportation Improvement Program (STIP); and
- WHEREAS,** the state transportation projects listed in the 2003 KPB Transportation Plan Appendix F and incorporated by reference into the 2005 KPB Comprehensive plan Chapter 5 are outdated; and
- WHEREAS,** state transportation projects must be included in an official plan in order for them to receive the highest possible score, according to the STIP scoring criteria; and
- WHEREAS,** Goal 1, Objective 7 of the KPB 2005 Comprehensive Plan is to regularly update the plan to reflect changing conditions, trends, laws, regulations and policies; and
- WHEREAS,** the Kenai Peninsula Borough Planning Commission reviewed the ordinance during its regularly scheduled meeting of April 13, 2009, and recommended enactment by unanimous consent;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That Appendix F: Alaska DOT&PF Statewide Transportation Improvement Program, Kenai Peninsula Borough Projects is hereby deleted from the 2003 KPB Transportation plan and Chapter 5, Transportation, of the 2005 KPB Comprehensive Plan.

SECTION 2. That a new Appendix J: Alaska DOT&PF Statewide Transportation Improvement Program Kenai Peninsula Borough Projects, is hereby adopted and incorporated into the 2003 KPB Transportation plan and Chapter 5, Transportation, of the 2005 KPB Comprehensive Plan.


SECTION 3. That this ordinance takes effect immediately upon its enactment.
