KENAI PENINSULA BOROUGH ORDINANCE 2009-19-31

AN ORDINANCE APPROPRIATING \$77,950.78 IN SUPPLEMENTAL FUNDING TO INITIATE PHASE II OF THE MINE ENGINEERING AND MANAGEMENT PLAN FOR THE SEWARD QUARRY

- WHEREAS, in May 2009, the borough solicited proposals from qualified firms to prepare a two phase Mine Engineering and Management Plan for the Seward Quarry; and
- WHEREAS, in September 2009, the Engineering Firm of Hattenburg Dilley & Linnell was selected and awarded a contract for the first phase of the project, a resource estimate and market study for \$58,500.00; and
- WHEREAS, the results of Phase I indicate that the Seward Quarry has over 1 million cubic yards of recoverable hard rock with royalty value exceeding \$3 million, a fraction of production value; and
- WHEREAS, the results of the Phase I study indicates that initiation of Phase II, preparation of Mine Engineering and Management Plans, is warranted; and
- WHEREAS, \$100,000 was initially budgeted in Land Management FY08 budget for Phase I, and there is currently \$31,779.22 available to support Phase II of the Mine Engineering and Management Plan for the Seward Quarry; and
- WHEREAS, a supplemental appropriation in the amount of \$77,950.78 from the Land Trust Fund is necessary to fund the Phase II project with a cost of \$109,730, to be completed by Hattenburg, Dilley and Linnell; and
- WHEREAS, at its meeting of April 26, 2010, the Planning Commission reviewed this proposed ordinance and recommended approval by unanimous consent;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$77,950.78 is hereby appropriated from the Land Trust Fund, fund balance, to the account 250.21210.8ROCK.43011 for contracting Phase II of the Mine Engineering and Management Plan for the Seward Quarry with the Engineering Firm of Hattenburg Dilley & Linnell. **SECTION 2.** This ordinance shall become effective immediately upon its enactment.
