**KENAI PENINSULA BOROUGH
ORDINANCE 2010-13**

**AN ORDINANCE AMENDING KPB 2.56.007 TO AMEND THE 2005 KENAI
PENINSULA BOROUGH COMPREHENSIVE PLAN BY ADOPTING THE COOPER
LANDING WALKABLE COMMUNITY PROJECT AS APPENDIX K IN CHAPTER 5,
TRANSPORTATION**

- WHEREAS,** Goal 5.4 of the 2005 Kenai Peninsula Borough (KPB) Comprehensive Plan is “To create trails or pedestrian walkways along highways and other busy roads, especially within communities”; and
- WHEREAS,** Objective 2 of Goal 5.4 is to “Include appropriate pedestrian facilities along roads built by or for the Borough that serve settled areas”; and
- WHEREAS,** the Sterling Highway passes through Cooper Landing, a community in the Kenai Peninsula Borough; and
- WHEREAS,** Cooper Landing has been included in the scope of a regional project involving a comprehensive plan for alternative transportation, from the Federal Transit Administration through the Native Village of Eyak; and
- WHEREAS,** meetings and workshops have been held by a community group of Cooper Landing citizens and many borough, state, and federal organizations and partners; and
- WHEREAS,** a list of project goals aimed at reducing congestion and road impacts and improving pedestrian facilities while maintaining access have been defined and prioritized; and
- WHEREAS,** three of the Walkable Community Project goals were adopted as 2010 State Capital Improvement Projects by the KPB Assembly in Resolution 2010-001; and
- WHEREAS,** adoption of the Cooper Landing Walkable Community Project as part of the borough’s comprehensive plan will assist in the acquisition of grant funds for the property listed in the plan; and
- WHEREAS,** the Kenai Peninsula Borough Planning Commission reviewed this ordinance during its regularly scheduled meeting of March 22, 2010, and recommended enactment by unanimous consent;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Kenai Peninsula Borough Assembly supports this project as a much needed enhancement to the quality of life for the residents and visitors of the Cooper Landing area.

SECTION 2. That KPB 2.56.007 is hereby amended to add subsection E as follows:


2.56.007. Borough plan amendments.

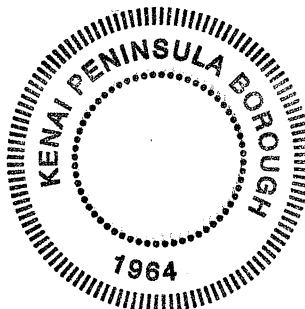
SECTION 3. That this ordinance takes effect immediately upon its enactment.
