underlying a portion of the Sterling Highway right-of-way

The Planning Commission reviewed the subject Ordinance during their regularly scheduled April 26, 2010 meeting. A motion passed by unanimous consent to recommend approval of the ordinance.

Staff Report reviewed by Marcus Mueller

The Borough owns the surface and mineral estate of the 22.07 acre parcel described as: Tract A-Aurora Vista Subdivision, Plat #HM-96-13 (PTI\T# 157-011-13). Marathon Alaska Production, LLC, currently has oil and gas leaseholds for 2100 subsurface acres of adjoining and surrounding parcels comprising the Ninilchik Unit, and has already developed the offsite infrastructure to extract natural gas from Tract A.

The Assembly recently enacted a new provision in Borough Code authorizing leases of oil and gas provided that those oil and gas leases would be excluded from the other provisions of KPB 17.10 wherein the oil and gas lease did not provide for any surface use. This would be a lease of the minerals and doesn't allow for any surface entry.

This lease had been previously requested each year by Marathon from 2002-2004, with follow-up correspondence in 2006 and 2007. The requested lease paperwork was inadvertently misplaced and through a series of apparent misunderstandings, Marathon has been extracting gas from the site for the past two years. Marathon has agreed to reimburse the borough at 12.5% for all back royalties that are due, which currently stands at \$171,693.00.

**Staff recommends** that the Planning Commission recommend the Assembly to adopt Ordinance 2010-18 thereby approving a subsurface oil & gas lease to Marathon Alaska Production, LLC.

#### END OF STAFF REPORT

Chairman Bryson opened the meeting for public comment. Seeing and hearing no one wishing to speak, Chairman Bryson closed the public comment period and opened discussion among the Commission.
