**KENAI PENINSULA BOROUGH
ORDINANCE 2010-19-01**

**AN ORDINANCE APPROPRIATING SUPPLEMENTAL FUNDING OF \$450,000
FOR COSTS ASSOCIATED WITH HOUSING THE MAGNETIC RESONANCE
IMAGING (MRI) MACHINE AT SOUTH PENINSULA HOSPITAL AND TRANSFER
\$180,000 IN UNENCUMBERED FUNDS FROM THE MRI EQUIPMENT PROJECT TO
THE MRI FACILITY PROJECT**

WHEREAS, at its May 5, 2009 meeting, the assembly enacted Ordinance 2008-19-51 which appropriated \$625,000 from interest earned from bond proceeds, to construct a building to house the hospital's new MRI, of which \$550,000 is available for construction; and

WHEREAS, based upon a design prepared by the borough's architect (RIM Architects), the construction firm on site (Jay-Brant General Contractors) estimated the cost to construct the building to be approximately \$986,134; and

WHEREAS, the Capital Projects Department estimates that this project can be constructed for less than \$1,175,948; and

WHEREAS, at its meeting of January 14, 2010, the South Peninsula Hospital Service Area Board (SPH) unanimously recommended approval of a request to appropriate \$300,000 from its Capital Project Fund to provide supplemental funding for the cost associated with housing the new MRI machine; and

WHEREAS, at its meeting of May 26, 2010, the South Peninsula Hospital Board of Directors approved funding for the MRI building in the amount of \$150,000; and

WHEREAS, the \$180,000 in unencumbered funds from the MRI equipment project, account number 491.81211.10SH2.48516, is available to support the facility to house the MRI;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$300,000 is appropriated from the SPH Capital Project Fund, Fund balance to account 400.94910.00000.50401, Transfer to the Bond Funded Capital Project Fund for costs associated with housing a new MRI at the South Peninsula Hospital and appropriated in account 401.81211.08SHB.49101.

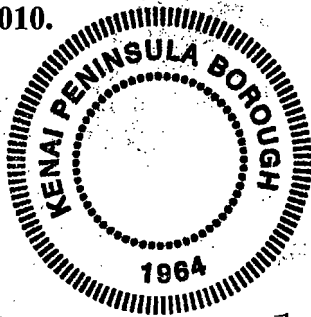
SECTION 2. That \$150,000 received from South Peninsula Hospital is appropriated in account 401.81211.08SHB.49101, for costs associated with constructing a facility for housing a new MRI at the South Peninsula Hospital.


SECTION 3. That \$180,000 in unencumbered funds from MRI Equipment Purchase project, account 491.81211.10SH2.48516, is transferred to the MRI facility project and appropriated in account 401.81211.08SHB.49101, for cost associated with constructing a facility to house a new MRI at South Peninsula Hospital.


SECTION 4. That this ordinance takes effect immediately upon its adoption.
