KENAI PENINSULA BOROUGH ORDINANCE 2010-19-08

AN ORDINANCE ACCEPTING AND APPROPRIATING \$20,000 FROM THE STATE OF ALASKA TO THE NORTH PENINSULA RECREATION SERVICE AREA FOR THE SHOWER REPLACEMENT PROJECT

- WHEREAS, the North Peninsula Recreation Service Area (NPRSA) submitted a request for funding to the state to replace the showers at the pool facility; and
- WHEREAS, Senate Bill 230, which appropriated funding to the borough for the project, was passed by the State Legislature and signed by the Governor on June 4, 2010; and
- WHEREAS, the borough has received notice from the Alaska Department of Commerce, Community and Economic Development that a legislative grant has been awarded to the borough in the amount of \$20,000 to NPRSA; and
- WHEREAS, at its regular meeting on June 28, 2010, the Service Area Board passed the motion recommending grant acceptance; and
- WHEREAS, the performance period for the state legislative grant is from July 1, 2010, through June 30, 2015, and does not require any matching funds; and
- WHEREAS, the DCCED grant award in the amount of \$20,000 will replace local funds that were appropriated to complete the project;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept, on behalf of the North Peninsula Recreation Service Area, a grant from the Department of Commerce, Community and Economic Development in the amount of \$20,000 for shower replacements, and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That acceptance of the above grant is subject to the requirement that the award of a contract or contracts for each project shall be submitted to the assembly for approval by resolution. No contract may be awarded until after the grant agreement for these funds has been executed by the borough and the state.

- SECTION 3. That grant funds in the amount of \$20,000 are hereby appropriated to 459.61110. 11031.49999.
- **SECTION 4.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 5. This ordinance shall become effective immediately upon its enactment.
