**KENAI PENINSULA BOROUGH  
ORDINANCE 2010-19-17**

**AN ORDINANCE APPROPRIATING \$10,898 FROM THE KACHEMAK EMERGENCY SERVICE AREA FUND BALANCE TO INCREASE THE SALARY FOR THE KACHEMAK EMERGENCY SERVICES ASSISTANT CHIEF POSITION BRINGING THE PAY RATE COMMENSURATE WITH THE POSITION AND A COMPETITIVE JOB MARKET**

**WHEREAS,** the FY2011 budget submitted by the mayor to the assembly included a salary increase for the assistant chief for Kachemak Emergency Services (Service Area); and

**WHEREAS,** the assembly did not approve this increase with the FY2011 budget; and

**WHEREAS,** on July 8, 2010, the KESA Board voted unanimously to ask the assembly to reconsider the salary increase; and

**WHEREAS,** on July 19, 2010, a letter from the KESA Board Chairman on behalf of the Service Area Board was sent to assembly member Haggerty requesting he sponsor the reconsideration; and

**WHEREAS,** the proposed salary increase brings the assistant chief's salary in line with equal and similar positions within the borough; and

**WHEREAS,** a year has passed since the assistant chief's hiring and an increase in salary is timely;


**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That \$10,898 is appropriated for a salary increase for the Kachemak Emergency Service Area Assistant Chief position and shall take effect November 1, 2010. Accounting to be disbursed in the following manner:


**SECTION 2.** That this ordinance takes effect immediately upon its enactment.
