KENAI PENINSULA BOROUGH ORDINANCE 2010-19-18

AN ORDINANCE REDIRECTING FUNDS PREVIOUSLY APPROPRIATED FOR REPAIRS TO NIKISKI FIRE STATION #2 AND APPROPRIATING \$40,000 FROM THE NIKISKI FIRE SERVICE AREA CAPITAL PROJECT FUND FOR BUILDING EXPENDITURES REQUIRED FOR CLOSEOUT OF LEASE AT OLD STATION #2

WHEREAS, the assembly through Ordinance 2007-19-01 appropriated \$50,000 for repairs to the hose tower and building deficiencies at Nikiski Fire Station #2; and

- WHEREAS, expenditures of \$9,093 were incurred in design and project management; and
- WHEREAS, with the completion of a new station #2, repairing the hose tower is no longer in the best interest of the service area or the landlord, the North Kenai Community Club; and
- WHEREAS, the Nikiski Fire Service Area Board (Service Area) has approved a plan for the old station #2, that would meet the Service Area's obligations with the North Kenai Community Club upon the expiration of the current rental agreement, which ends October 31, 2010; and
- WHEREAS, as the intent of the original appropriation has changed, at its September 8, 2010 meeting the Service Area board recommended that the remaining balance of the original appropriation be redirected and reappropriated for purchase of wildland firefighting equipment and authorized that \$40,000 from the Service Area Capital Project fund balance be appropriated towards necessary expenditures for the close out of the Service Area's lease agreement for old station #2;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That unspent funds from project number 262.21320.8INT3.49999 in the amount of \$40,907 are redirected and appropriated to the Nikiski Fire Service Area Capital Project fund account 441.51110.8INT3.49999 for wildland firefighting equipment.
- **SECTION 2.** That \$40,000 is appropriated from the Nikiski Fire Service Area Capital Project Fund, fund balance, to account no. 441.51110.110LD .49999, for expenditures as needed to close out the current rental agreement for old station #2.

SECTION 3. That this ordinance takes effect immediately upon its enactment.
