KENAI PENINSULA BOROUGH ORDINANCE 2010-19-21

AN ORDINANCE APPROPRIATING \$27,994 IN SUPPLEMENTAL FUNDING AND AUTHORIZING THE HIRING OF A ONE-HALF TIME VEHICLE MAINTENANCE EMPLOYEE FOR THE ANCHOR POINT FIRE AND EMERGENCY MEDICAL SERVICE AREA

- WHEREAS, a mechanical review by the Central Emergency Services mechanic of all the Anchor Point Fire and Emergency Medical Service Area (Service Area) response vehicles revealed a number of deficiencies that need to be addressed; and
- WHEREAS, the Service Area Board has been working diligently to repair the deficiencies that were identified on the response vehicles; and
- WHEREAS, the Service Area Board believes hiring a part time employee who is certified to work on the response vehicles would assist it in its endeavor to repair the noted deficiencies and maintain the vehicles in accordance with National Fire Protection Association (NFPA) standards; and
- WHEREAS, the Service Area Board at its September 27, 2010, meeting authorized the hiring of a one-quarter time vehicle maintenance employee to assist the Service Area in maintaining its vehicles; and
- WHEREAS, the Service Area board at its November 4, 2010, special meeting recommended that the one-quarter time mechanic position be increased to a one-half time mechanic position; and
- WHEREAS, the estimated cost of a one-half time employee including benefits is \$27,994;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the assembly approves a one-half time mechanic position for the Anchor Point Fire and Emergency Service Area that requires the mechanic to be certified as required by NFPA standards to perform the required services.
- SECTION 2. That \$27,994 is appropriated from the Anchor Point Fire and Emergency Medical Service Area, Fund Balance to the following accounts for cost associated with a one-half time mechanic position at Anchor Point Fire and Emergency Service Area:
