**KENAI PENINSULA BOROUGH  
ORDINANCE 2010-42**

**AN ORDINANCE REVISING KPB 16.60.040, POWERS AND DUTIES OF THE  
ANCHOR POINT FIRE AND EMERGENCY MEDICAL SERVICE AREA BOARD, TO  
STATE IT IS RESPONSIBLE TO PROVIDE FOR THE EMERGENCY SERVICES AND  
TO MAKE RECOMMENDATIONS TO THE MAYOR AND ASSEMBLY REGARDING  
SERVICE AREA ACTIVITIES**

**WHEREAS,** on October 4, 1983, the voters in the area of Anchor Point voted for the establishment of a fire and ambulance service area known as the "Anchor Point Fire and Emergency Service Area" (APFEMSA); and

**WHEREAS,** Kenai Peninsula Borough Code 16.48.040, re-codified at 16.60.040, established the powers and duties of the APFEMSA board; and

**WHEREAS,** the current description of the APFEMSA board's powers and duties in KPB 16.60.040 does not adequately meet the service area's needs and requires modification to clearly allow the board to contract out for the emergency services provided while remaining responsible for ensuring that requirements for emergency services in the Anchor Point Service Area are met; and

**WHEREAS,** the APFEMSA board is and has been responsible for ensuring that the nonprofit satisfy its contractual duties and that the service area fulfill its duty to provide oversight of the required services; and

**WHEREAS,** at its meeting of December 20, 2010, the Anchor Point Fire and Emergency Service Area Board recommended that Ordinance 2010-42 be postponed and revisited in 12 months;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That KPB 16.60.040 be amended as follows:

**16.60.040. Powers and duties.**

The board of directors of the service area, subject to assembly approval and appropriation of funds, shall provide for [SUPERVISE] the establishment and operation of the fire and emergency medical services within the service area, and shall inform and make recommendations to [ADVISE] the mayor and the


assembly concerning the administration and operation of the service area. The service area board shall promptly furnish accurate and complete copies of the minutes of all board meetings to the mayor and assembly.

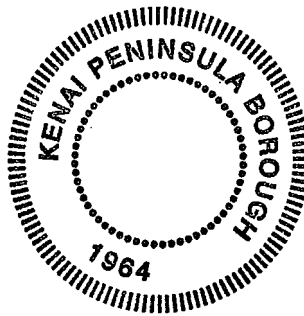
**SECTION 2.** That this ordinance takes effect immediately upon its enactment.
