NOW, THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH RESOLVES:

1. Declares proposition no. 1 to be approved Edward E. Hollier to be elected a member of the Borough School Board for a five (5) year term, Jack C. Farnsworth to be elected a member of the Borough Assembly for a three (3) year term, Harold A. Jackson to be elected a member of the Borough Assembly for the two (2) remaining years of an unexpired three year term.

2. Takes note there was not a quorum for the assembly meeting on October 12, 1964 but that the election board of the Soldotna precinct presented to the assemblymen and the Borough Chairman assembled at that time a valid certificate of results of the election and that assemblymen elect Farnsworth and Jackson thereupon subscribed to their oaths of office.
3. Declares Jack C. Farnsworth and Harold Jackson to have been validly sworn in as members of the assembly in substantial compliance with the election procedures and that they are members of the assembly.
