A RESOLUTION CERTIFYING THE RESULTS OF THE SPECIAL ELECTION OF FEBRUARY 25, 1975

WHEREAS, THE Assembly has received from the Canvassing Board the Kenai Peninsula Borough "Certificate of Results" of the Special Bond Election held on February 25, 1975, and

WHEREAS, the "Certificate of Results" records the following:

PROPOSITION I:

Shall Ordinance 74-71 be approved, by which the Kenai Peninsula Borough, instead of accumulating funds for cash payment of such project is allowed to incur indebtedness in an amount not to exceed \$3,500,000 for the purpose of raising funds for Constructing and equipping an addition to the Kenai Central High School consisting of a swimming pool, an additional athletic area, an addition of eight classrooms to the educational complex, a music room, and some renovation of the present building, with payment of such indebtedness to be derived from taxes levied within the Kenai Peninsula Borough and from such other revenues as may be properly pledged for such payment, with the full faith and credit and resources of the Kenai Peninsula Borough pledged for the repayment of the indebtedness so incurred?

PROPOSITION II: Shall ordinance 74-73 be approved by which the Kenai Peninsula Borough is allowed to incur indebtedness in an amount not to exceed \$1,974,000 for the purpose of raising funds for constructing and equipping the following schools:

East Homer Elementary School, 6 classroom addition in the amount of \$611,000;

Soldotna, Elementary School, 8 classroom addition in the amount of \$812,000;

with payment of such indebtedness to be derived from taxes levied within the Kenai Peninsula Borough and from such other revenues as may be properly pledged for such payment, with the full faith and credit and resources of the Kenai Peninsula Borough pledged for the repayment of the indebtedness so incurred?
