## RESOLUTION 75-10

A RESOLUTION URGING THAT HOUSE BILL NO. 3 PROVIDING AUTHORITIES FOR A MUNICIPALITY TO REQUIRE THAT ALL PLATS PROVIDE FOR DEDICATION OF OPEN SPACE, PARK, OR RECREATION AREAS WITHIN THEIR BOUNDARIES BE DEFEATED.

WHEREAS, House Bill No. 3 has been introduced in the first session of the Ninth Legislature of the State of Alaska to provide authority for a municipality to require that all plats provide for dedication of open space, park, or recreation areas; and

WHEREAS, Section 18 of the Constitution of the State of Alaska provides that "Private property shall not be taken or damaged for public use without just compensation", and the Fifth Amendment to the Constitution of the United States of America provides "nor shall private property be taken for public use, without just compensation"; and

WHEREAS, the requirement which would be authorized by House Bill No. 3 is obviously in conflict with the cited portions of the Constitutions of the State of Alaska and of the United States of America since no compensation is required to be made for such taking: and

WHEREAS, AS 40.15 provides that plats must be filed for every subdivision, and AS 40.15.190 (2) defines "subdivision" as meaning any division of a tract or parcel of land into two or more lots, sites, or other divisions for the purpose, whether immediate or future, of sale or building development, and thus anyone selling any portion of a piece of property less than the whole could be required to furnish lands for open space or parks without any payment therefor and whether or not open space or parks were needed by the municipality;
