NOW, THEREFORE, THE ASSEMBLY OF THE KENAI PENINSULA  
BOROUGH DECLARES:

1. That Tommy Corr, John C. Davis, and Jean B. Douglas received 736, 840, and 850 votes respectively and are elected to three year terms on the borough assembly having each received in excess of 40% (402) of the votes cast for those seats and Margaret A. Branson received 1009 votes and is elected to a 1 year term on the borough assembly.

2. That Joyce W. Fischer and Sandra G. Morris received 2035 and 1789 votes respectively and are elected to 3 year terms on the school board; Sheila Owens having received 2200 votes is elected to a 2 year term and Sharon M. Brower having received 1313 votes is elected to a 1 year term on the school board.

3. That the following candidates received the highest votes for positions on the South Peninsula Hospital Service Area Board and are hereby elected to terms as follows:

Seat A, 3 year term - Gene R. Williams  
Seat B, 3 year term - Marguerite Jacobs (writein)  
Seat E, 2 year term - Leroy Gannaway

Seat C received a total of 133 write-in votes and as no write-in received 40% of the total cast, Richard Dixon and Dan Hennick with 23 and 32 votes respectively will be candidates in a runoff election scheduled for October 26, 1976.

4. That the following candidates received the highest vote for positions on the North Peninsula Recreation Service Area Board and are hereby elected to terms as follows:

Seat A, 1 year term - Roger "Bud" Harris  
(write-in candidate)  
Seat B, 1 year term - Jean B. Douglas  
Seat C, 3 year term - Chester G. Brown  
Seat D, 3 year term - Charles P. Koehler

5. That the following candidates received the highest vote for positions on the North Kenai Fire Service Area Board and are hereby elected to 3 year terms:

Seat D - Mahlon C. Morris  
Seat E - Charles P. Koehler


6. That Proposition A received 210 votes for "Nikiski Fire Service Area" and is hereby approved by the voters of the North Kenai Fire Service Area.

7. That Proposition B received 881 "Yes" votes and 740 "No" votes and hereby was approved by the voters of the Central Peninsula Hospital Service Area.
