RESOLUTION 81-111

AWARDING A YEAR TO YEAR CONTRACT FOR THE MAINTENANCE OF THE KENAI AND SCLDOTNA LANDFILLS FOR A PERIOD OF FIVE YEARS TO ROBINSON CONSTRUCTION COMPANY, SUBJECT TO AN ANNUAL APPROPRIATION OF \$383,710.

WHEREAS, the Borough has solicited and opened bids for the performance of combined maintenance and necessary capital improvements of the Kenai and Soldotna Landfills for a contract period of five years; and

WHEREAS, the low bidder was Robinson Construction Company, which proposed to perform all necessary work for the five year period for the sum of \$1,918,550, for an average amount of \$383,710 per year for the combined maintenance of the landfills; and

WHEREAS, the continuation of the contract from year to year within the five year period shall be contingent upon appropriation of necessary sums by the Borough Assembly; and

WHEREAS, funds appropriated for the first year of the contract term are sufficient and the Department of Public Works recommends the award of the contract to Robinson Construction Company;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the bid of Robinson Construction Company to perform all required maintenance and capital improvement work to the Kenai and Soldotna Landfills for a period of five years, at the average cost of \$383,710 per year, is accepted and a contract is awarded. The continuation of the contract from year to year shall be contingent upon the appropriation of sufficient funds by the Assembly for that budget year; the Borough and the contractor specifically agree and understand that the contract is severable from year to year.

Section 2. All maintenance work to the Kenai Landfill shall be charged to the Kenai Landfill Maintenance Account Number 01-41721-3400. All maintenance work to the Soldotna Landfill shall be charged to the Soldotna Landfill MAintenance Account Number 01-41726-3400. All capital improvement site work

All capital improvement site work to the Soldotna Landfil shall be charged to the Soldotna Landfill Site Work Capital Improvement Account Number 63-28880-9210. Allocations among these accounts shall be made in conformance with the allocation provided by the bid.

Section 3. That the Mayor is authorized to effectuate this resolution, which takes effect immediately upon its adoption.
