WHEREAS, Mr. George Robinson of Robinson Construction Company has requested to be released from the contract for maintaining the Homer Landfill due to economic difficulties; and

WHEREAS, the Department of Public Works recommends releasing Robinson Construction from this contract; and

WHEREAS, Herndon and Herndon Construction was the next low bidder when this project was bid in 1980; and

WHEREAS, the Borough is in the process of establishing a baler at the landfill which will substantially alter the nature and cost of maintaining the Homer Landfill; and

WHEREAS, the Department of Public Works has recommended awarding an interim contract to Herndon and Herndon Construction for the maintenance of the Homer Landfill until such time as the baler is in operation in the amounts previously bid and the contractor has affirmed his willingness to perform this work upon the terms of the bid;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: That Robinson Construction is released from any and all contractual obligations regarding the maintenance of the Homer Landfill provided that;

- 1. All retainage held against the contract is forfeited to the Borough.
- Robinson Construction releases and agrees to hold harmless the Borough for any and all losses he has sustained as a result of his request.

Section 2: That the proposal of Herndon and Herndon Construction to maintain the Homer Landfill for the period
