RESOLUTION 81-162

ACCEPTING THE PROPOSAL OF MIKE TAURIAINEN, P.E., TO PROVIDE COMPLETE SURVEY AND DESIGN SERVICES FOR THE HALIBOUTY ROAD AND HOLT ROAD PROJECTS.

WHEREAS, the Borough desires to provide for the upgrading and paving of Halibouty Road and Holt Road in the Nikiski area; and

WHEREAS, the Borough has requested proposals to provide all services necessary for the design of these projects, including surveying, soils investigation, materials testing, road design and preparation of construction plans and specifications; and

WHEREAS, the consulting firm of Mike Tauriainen, P.E., has proposed to perform all necessary work for the Halibouty Road Project in an amount not to exceed \$51,100, and for the Holt Road Project in an amount not to exceed \$42,300; and

WHEREAS, sufficient funds are available for these priority projects and the Department of Public Works has recommended that the proposal of Mike Tauriainen, P.E., be accepted;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the proposal of Mike Tauriainen, P.E., to perform all survey, soils investigation, materials testing, road design, and preparation of construction plans and specifications for the upgrading and paving of Halibouty Road, for the amount not to exceed \$51,100, is accepted, and to perform these same services in connection with the upgrading and paving of Holt Road in an amount not to exceed \$42,300, is accepted, and that a contract is awarded. All expenditures for the Halibouty Road Project shall be charged to Halibouty Road Contingency Account No. 66-21037-9007 and all expenditures for the Holt Road Project shall be charged to Holt Road Contingency Account #65-21038-9007.

Section 2. That the sum of \$56,000 is transferred from the Road Design Contingency Account No. 66-21001-9007 to the Halibouty Road Contingency Account #66-21037-9007 and that the sum of \$46,500 is transferred from the Road Design Contingency

Account No. 65-21001-9007 to the Holt Road Contingency Account
No. 65-21038-9007.

Section 3. That the Mayor is authorized to effectuate
this resolution, which takes effect immediately upon its
adoption.
