AWARDING A CONTRACT TO MCLANE & ASSOCIATES TO CONDUCT PRELIMIN-ARY SURVEY WORK FOR THE BEAN CREEK ROAD PROJECT AND FOR THE LAMPLIGHT ROAD PROJECT.

WHEREAS, the Assembly desires to provide for the upgrading of Bean Creek Road and of Lamplight Road as priority projects; and

WHEREAS, the Borough cannot proceed with design of these projects until the proposed road alignments have been surveyed and topographical maps prepared, so that the most desirable road alignments may be identified; and

WHEREAS, the firm of McLane & Associates has proposed to perform all necessary survey and mapping work for the Bean Creek Road Project for an amount not to exceed \$13,600 and for the Lamplight Road Project for an amount not to exceed \$42,800; and '

WHEREAS, the Department of Public Works has examined the proposal and recommends the award of a contract to McLane & Associates to perform this survey work; and

WHEREAS, the survey work accomplished under this contract will be incorporated into the final design of these roads;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the proposal of McLane & Associates to perform preliminary survey and topographical mapping work for the Bean Creek Road Project in an amount not to exceed \$13,600, and for the Lamplight Road Project in an amount not to exceed \$42,800, is accepted and a contract is awarded. All expenditures for the Bean Creek Road Project shall be charged to Account No. 65-21046-9007 and all expenditures for the Lamplight Road Project shall be charged to Account No. 66-21041-9007.

Section 2. That the sum of \$15,000 is transferred from the Road Design Contingency Account No. 65-21001-9007 to the Bean Creek Road Contingency Account No. 65-21046-9007 and that the sum of \$47,000 is transferred from the Road Design

Section 3. That the Mayor is authorized to effectuate this resolution, which takes effect immediately upon its adoption.
