RESOLUTION 81-185

DELINEATING BOROUGH LANDS AT THE SOLDOTNA LANDFILL TO INCLUDE A BUFFER ZONE.

WHEREAS, the Borough has operated the Soldotna Landfill as a part of its solid waste disposal program; and

WHEREAS, the original area of the Soldotna Landfill has been used to capacity; and

WHEREAS, the Department of Public Works has identified the need to add lands to the south of the existing Soldotna Landfill in order to continue solid waste disposal operations at the landfill; and

WHEREAS, the residents of the area have objected to the addition of these lands to the south of the landfill; and

WHEREAS, the provision for a Buffer Zone is in the public interest;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the lands of the Soldotna Landfill and related Buffer Zones are described as:

"S $\frac{1}{2}$, SE $\frac{1}{2}$, Section 12 plus the NE $\frac{1}{4}$ of Section 13 all of Township 4 North, Range 11 West of the Seward Meridian, Alaska"

The lands within this area comprising the Soldotna Landfill solid waste disposal areas and covering material source areas, are described as:

"E $\frac{1}{2}$, SW $\frac{1}{4}$, SW $\frac{1}{4}$, SE $\frac{1}{4}$ plus SE $\frac{1}{4}$, SW $\frac{1}{4}$, SE $\frac{1}{4}$, plus SW $\frac{1}{4}$, SE $\frac{1}{4}$, SE $\frac{1}{4}$ of Section 12 plus NE $\frac{1}{4}$, NW $\frac{1}{4}$, NE $\frac{1}{4}$, plus NW $\frac{1}{4}$, NE $\frac{1}{4}$, NE $\frac{1}{4}$, of Section 13 all of Township 4 North, Range 11 West of the Seward Meridian, Alaska"

The Assembly resolves that all areas not included in the described landfill area are established Buffer Zones, and the

lands designated as Buffer Zones shall not be used for landfill operations without the approval of the Assembly. The landfill area and the Buffer Zones are shown on the attached map which is incorporated and made a part of this resolution.

Section 2: This resolution takes effect immediately upon its adoption.
