RESERVING PUBLIC USE EASEMENTS UPON LANDS INCLUDED IN THE NINILCHIK SEALED BID AUCTION.

WHEREAS, the Borough intends to sell by sealed bid certain lands lying generally near Ninilchik in December, 1981; and

WHEREAS, the Planning Commission has recommended that these lands be sold, subject to the reservation of certain public use easements; and

WHEREAS, the Assembly finds that the Borough shall reserve from conveyance the public use easements recommended by the Borough Planning Commission in order to provide for access to lands adjacent to these Borough lands, and to provide for public access to public waterways;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1: That the Assembly reserves from conveyance the following described public use easements from the lands to be conveyed by the December, 1981 Ninilchik sealed bid sale of Borough-selected lands:

Unit 1: A 50 foot wide public use easement more particularly described as the North 50 ft. of Government Lot 1, Sec. 26, T1S, R14W, Seward Meridian, Alaska.
