RESOLUTION 81-197

APPROVING THE USE OF THE NE $\frac{1}{4}$  NW $\frac{1}{4}$  NE $\frac{1}{4}$ , NW $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  OF SECTION 13, T4N, R11W, S.M., AS A PART OF THE SOLDOTNA LANDFILL.

WHEREAS, the Alaska Department of Environmental Conservation (ADEC) has authorized by permit, after public hearing, the use of the NE $\frac{1}{4}$  NW $\frac{1}{4}$  NE $\frac{1}{4}$ , NW $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 13, T4N, R11W, S.M., as a part of the Soldotna Landfill; and

WHEREAS, the land contained in Section 13 adjoins land in Section 12 constituting a pothole resulting from a drained lake which will be used for the landfill operation; and

WHEREAS, the Soldotna Landfill has been planned to include as solid waste disposal areas and cover material source areas the lands described as:

"E $\frac{1}{2}$ , SW $\frac{1}{4}$ , SW $\frac{1}{4}$  SE $\frac{1}{4}$  plus SE $\frac{1}{4}$ , SW $\frac{1}{4}$  SE $\frac{1}{4}$ , plus SW $\frac{1}{4}$ , SE $\frac{1}{4}$ , SE $\frac{1}{4}$  of Section 12 plus NE $\frac{1}{4}$ , NW $\frac{1}{4}$ , NE $\frac{1}{4}$ , plus NW $\frac{1}{4}$ , NE $\frac{1}{4}$ , NE $\frac{1}{4}$ , of Section 13 all of Township 4 North, Range 11 West of the Seward Meridian, Alaska."

WHEREAS, considerable controversy has arisen over the use of that part of the pothole located in Section 13;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Assembly approves the use of the NE $\frac{1}{4}$  NW $\frac{1}{4}$  NE $\frac{1}{4}$ , NW $\frac{1}{4}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 13, T4N, R11W, S.M., as a part of the solid waste disposal areas and cover material source areas of the Soldotna Landfill in accordance with the permit issued by the Alaska Department of Environmental Conservation (ADEC).

Section 2. That this resolution takes effect immediately upon its adoption.
