RESERVING PUBLIC USE EASEMENTS FROM BOROUGH LANDS WHICH ARE INCLUDED IN BOROUGH LOTTERY LAND SALE NO. 2 IN ORDER TO PRESERVE ACCESS AND OTHER PURPOSES IN THE PUBLIC INTERESTS.

WHEREAS, the Assembly on April 21, 1981, enacted Ordinance 81-23 (Substitute) disposing to the general public by lottery of certain Borough selected lands; and

WHEREAS, this sale is known as Borough Lottery Land Sale No. 2 and contains approximately 250 acres of land; and

WHEREAS, this Borough Lottery Land Sale No. 2 consists of 15 land units ranging in size from approximately 4 acres to 51 acres; and

WHEREAS, some of these parcels are located just north of the Kenai city limits, and other parcels are scattered along Kalifonsky Beach Road and others southerly towards Homer; and

WHEREAS, there exists public use requirements in order to provide access and other public interest uses; and

WHEREAS, the Assembly finds that the Borough should reserve such public use easements so that the Borough Lottery Land Sale No. 2 will be subject to such public use easements;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Assembly as owner of the real property, hereby reserves unto itself for the benefit of the public, public use easements in the following described real estate designated by parcel numbers:






