Section 2. That a contract in an amount not to exceed \$9,721 is awarded to Steve Wolfe for landscaping services as contained in the bid response for the period of the 1981 growing season.

Section 3. That a contract in an amount not to exceed \$13,760.77 is awarded to Ward Services for landscaping services as contained in the bid response for the period of the 1981 growing season.

Section 4. That a contract in an amount not to exceed \$10,390 is awarded to Hugh Q. Smith for landscaping services as contained in the bid response for the period of the 1981 growing season.
