AUTHORIZING A SUPPLEMENTAL CADASTRAL SURVEY OF SECTIONS 18 AND 19 OF T8N, R17W AND SECTIONS 13 AND 24 OF TRACT A T8N, R18W, SEWARD MERIDIAN, ALASKA.

WHEREAS, the Borough solicited detailed proposals to survey by Cadastral Survey and to produce a 10-foot contour topographical map of land on the Big River Lakes Project Supplemental Cadastral Survey GSI 79-55; and

WHEREAS, the project includes cadastral surveying according to instructions issued by the State of Alaska, Department of Natural Resources, Division of Technical Services; and

WHEREAS, aerial photographs will be taken of the area at a convenient flying height to produce a 10-foot contour topographical map; and

WHEREAS, the survey is being made in conjunction with the State of Alaska, and all plats will meet the standards as set forth by the State of Alaska; and

WHEREAS, the Planning and Resources Development Department of the Borough recommends that a contract be authorized and entered into to accomplish this cadastral survey as soon as possible;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the scope of professional services negotiated between the Borough and Alaska Land Surveys, Raymond M. Burgess, RLS, P. O. Box 1085, Seward, Alaska 99664, is accepted and the Mayor is authorized to enter into a contract for a total contract price of \$30,000 for the aerial photography, topographic mapping, and supplemental cadastral survey of Sections 18 and 19 of T8N, R17W and Sections 13 and 24 of Tract A T8N, R18W, Seward Meridian, Alaska. The contract is for professional services to be performed and paid in increments on the following basis:

Section 2. The surveyor is to submit the final plat to the Division of Technical Services of the State Department of Natural Resources within 60 days after June 1, 1981. The contract shall contain the requirements set forth in the solicitation for proposals dated March 26, 1981, and GSI 79-55 of the Division of Technical Services dated December 19, 1980, and December 10, 1979, and shall contain such other provisions as may be mutually agreed upon between the parties in order to accomplish the cadastral survey in accordance with the requirements and objectives of the Borough and the State of Alaska Division of Technical Services.

Section 3. This resolution takes effect immediately upon its adoption.
