SETTING THE RATE OF LEVY FOR REAL AND PERSONAL PROPERTY TAXES FOR THE KENAI PENINSULA BOROUGH AND FOR SERVICE AREAS WITHIN THE BOROUGH FOR THE TAX YEAR 1981.

BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the rate of levy of taxes on all real and personal property within the Kenai Peninsula Borough for the tax year of 1981 is hereby set at 2.5 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

Section 2. That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of taxes on all real and personal property within the Nikiski Fire Service Area for said area for the tax year of 1981 is hereby set at 1.80 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

Section 3. That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of taxes on all real and personal property within the South Peninsula Hospital Service Area for said area for the tax year of 1981 is hereby set at 1.78 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

Section 4. That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of taxes on all real and personal property within the North Peninsula Recreation Service Area for said area for the tax year of 1981 is hereby set at .31 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of taxes on all real and personal property within the Bear Creek Fire Service Area for said area for the tax year of 1981 is hereby set at 3.79 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

Section 6. That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of taxes on all real and personal property within the Central Peninsula Hospital Service Area for said area for the tax year of 1981 is hereby set at .51 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

Section 7. That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of Ridgeway Fire Service Area for said area for the tax year of 1981 is hereby set at 2.0 mills on each one dollar of assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.

Section 8. That in addition to any other rate or rates of levy applicable for other purposes, the rate of levy of taxes on all real and personal property within the Kenai River Bridge Road Service Area for said area for the tax year of 1981 is hereby set at 0.0 mills on each one dollar or assessed value as determined by the assessment roll and any supplemental rolls hereafter certified by the Borough Assessor.
