RESOLUTION 82-144

PROVIDING FOR EXECUTIVE AND ADMINISTRATIVE SALARY ASSIGNMENTS
FOR BOROUGH STAFF DEPARTMENT HEADS AND OTHER EXEMPT
PERSONNEL.

WHEREAS, the Assembly has delegated to the Mayor the
authority to establish administrative and executive salaries;
and

WHEREAS, there has been only one general staff base
salary adjustment since July, 1977;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE
KENAI PENINSULA BOROUGH:

Section 1. That staff department heads will receive an
annual salary not to exceed the following amounts:

Administrative Officer	\$56,000
Attorney	\$55,000
Finance Director	\$55,000
Public Works Director	\$55,000
Assessor	\$55,000
Maintenance Superintendent	\$55,000
Clerk	\$50,000
Central Peninsula Emergency Medical Services Director	\$35,854

Section 2. That administrative assistants and other
employees not covered under the Collective Bargaining
Agreement will receive an annual salary not to exceed:

Data Processing Supervisor	\$47,500
Assistant Finance Director	\$51,000
Administrative Assistant/ Resource Development	\$42,000
Administrative Assistant/ Civil Defense/Personnel	\$40,000
Surveyor	\$42,000
Deputy Clerk	\$35,000
Nikiski Fire Chief	\$47,407
Ridgeway Fire Chief	\$38,500
Borough Pool Manager	\$26,700
Training & Operations Director	\$44,178
Medical Rescue Services Director	\$41,189

Section 3. That whenever a middle-management employee assigned to Section 2(b) of Appendix A of the Borough's Collective Bargaining Agreement with the Kenai Borough Employees Association, transfers to Section 1 of Appendix A, such employee will receive an annual salary not to exceed the amount listed:

Senior Planner	\$42,000
Assistant Assessor	\$51,000
Engineer	\$53,000
Assistant Maintenance Superintendent	\$49,000
Deputy Superintendent	\$42,000

Section 4. That this pay schedule shall be retroactive to June 28, 1982.

Section 5. That this resolution takes effect on the date of its adoption.
