RELATING TO THE ESTABLISHMENT, MODIFICATION AND ALLOCATION OF CERTAIN BOROUGH PERSONNEL POSITIONS AND PAY RANGES TO REFLECT THE 1982-83 BOROUGH BUDGET.

WHEREAS, the budget process was in progress at the same time that the negotiations were undertaken with the Employees' Association for the renewal of the collective bargaining agreement with the Borough; and

WHEREAS, it was necessary to make modifications to certain personnel ranges, job descriptions and upgrade of duties for certain positions which in turn affected some pay ranges; and

WHEREAS, the Assembly by Ordinance 81-88 enacted on September 1, 1981 amended Title 3 of the Borough Code of Ordinances relating to personnel and authorized the Assembly by resolution to authorize positions of employment and to effectuate changes in the classified service designations where it was necessary to conform to the Borough's approved annual budget; and

WHEREAS, in the 1982-83 annual budget certain modifications, positions, duties, upgrades and certain pay scales were affected by the concurrent labor negotiations; and

WHEREAS, it is desirable to make the authorized personnel classifications, positions and salary ranges contained in the 1982-83 annual budget conform to the amounts reflected in the funds appropriated in the respective departmental budgets;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the section of the Borough's Annual Budget for 1982-83 entitled "Authorized Personnel And Hours By Activity" appearing at or about Page 129 - 133 of the approved annual budget document as authorized by Ordinance 82-34 enacted on June 1, 1982 is amended to read:
