## RESOLUTION 82-15

REPEALING RESOLUTION 81-204 AND REALLOCATING MUNICIPAL ASSISTANCE GRANT FUNDS TO VARIOUS CAPITAL IMPROVEMENT PROJECTS WITHIN THE BOROUGH.

WHEREAS, the Assembly by Resolution 81-146 and by Resolution 81-204 has allocated municipal assistance capital improvement grant funds received from the State of Alaska; and

WHEREAS, the Assembly desires to provide for the construction of the Resurrection River Footbridge; and

WHEREAS, the Assembly desires to identify the specific capital improvement projects upon which it intends to spend municipal assistance grant funds;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the project designations and the allocations of funds set forth in this resolution supercede those set out in Resolution 81-204 and in Resolution 81-146, both of which are hereby repealed.

Section 2. That the \$7,331,640 received from the State Assistance for Municipalities Program for the year 1981-82 will be expended as follows to upgrade existing facilities:
