RESOLUTION 82-175

AMENDING RESOLUTION 82-154, AND REALLOCATING MUNICIPAL ASSISTANCE GRANT FUNDS TO VARIOUS CAPITAL IMPROVEMENTS PROJECTS WITHIN THE BOROUGH.

WHEREAS, the Assembly, by Resolution 82-154 has allocated municipal assistance capital improvement grant funds received from the State of Alaska; and

WHEREAS, the State of Alaska, Department of Transportation has opened bids on the Ninilchik Cemetery Road in connection with the Kingsley-Oilwell Road Project; and

WHEREAS, funds appropriated by the Alaska Legislature are not sufficient to complete the Ninilchik Cemetery Road which is ready to construct; and

WHEREAS, the Ninilchik Cemetery Road could not be constructed prior to 1984, if the Borough does not participate in the cost of the project; and

WHEREAS, any delay will increase the cost of the project; and

WHEREAS, there are unexpended surplus funds in the Holt Road Account sufficient to cover the costs of the Ninilchik Cemetery Road Project.

NOW THEREFORE BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the unexpended amount of \$60,000.00 in Holt Road account 65-21038-9007 is transferred to Ninilchik Cemetery Road account 65-21051-9007.

Section 2. That these funds shall be transferred to the State of Alaska Department of Transportation in order to facilitate the construction of Ninilchik Cemetery Road.


Section 3. That the expenditures for all projects shall read as follows:
