ADDITION FOR A CERTIFICATE OF

AUTHORIZING THE APPLICATION FOR A CERTIFICATE OF SELF-INSURANCE ASSURING THE PAYMENT OF WORKMEN'S COMPENSATION BENEFITS UNDER THE ALASKA WORKMEN'S COMPENSATION ACT TO PERMIT THE BOROUGH AND THE SCHOOL DISTRICT TO ACT AS SELF-INSURER OF WORKMEN'S COMPENSATION CLAIMS.

WHEREAS, the Alaska Workmen's Compensation Act provides for the Certificate of Self-Insurance of any employers or organizations which have the proven ability to pay benefits which become due to employees instead of obtaining third-party insurance coverage; and

WHEREAS, the School Board adopted a resolution on November 2, 1981 which approved the self-insurance of the School District's employees under the Alaska Workmen's Compensation Act; and

WHEREAS, the Borough general government employees are subject to the Borough's self-insurance certification regarding workmen's compensation;

NOW THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

Section 1. That the Borough is authorized to make application for the Borough and on behalf of the School District to include the Borough and the School District on the Borough's Certificate of Self-Insurance assuring the payment of workmen's compensation benefits as provided by the Alaska Workmen's Compensation Act. This authorization shall be effective during Fiscal Year 1981-1982 subject to the Alaska Workmen's Compensation Board rules and regulations and may be renewed from year to year if the Workmen's Compensation Board is satisfied that the Borough and the School District have complied with provisions of the Alaska Workmen's Compensation Act and have the financial ability to pay the benefits provided for in that law.
